12 **CUSTODIAN'S FIRST INTERIM STATUS REPORT**

13 On June 29, 2021, pursuant to NRS 78.347, this Court appointed Shareholders First, LLC
14 as the custodian of Wally World Media, Inc. ("WLYW" or the "Corporation"), to revive and
15 rehabilitate this abandoned Nevada corporation¹. The Custodian hereby reports on its activities
16 as Custodian pursuant to NRS 78.347(3)(d) and the Order Appointing Custodian on file in this
17 case (the "Order").

18 **I. ACTIONS TAKEN BY CUSTODIAN DURING THE INTERIM PERIOD**

19 Pursuant to the Order, Custodian has performed the following actions:

- 20 1. On June 30, 2021, the Custodian paid all fees and caused filing of all necessary
21 paperwork with the Nevada Secretary of State ("NVSOS") to revive the formerly
22 abandoned Nevada Corporation's charter. The Corporation is now active and in
23 good standing with the State of Nevada.²

2. Custodian also filed the required Custodianship Amendment to the Company's Articles of Incorporation with the NVSOS, as ordered by this Court.
3. Custodian appointed a new registered agent for the Corporation.
4. Custodian appointed interim officers and directors to serve until the Company's next meeting of shareholders.
5. Custodian has paid all past due invoices owed to the Company's transfer agent, VSTOCK TRANSFER, LLC, and has now obtained a current copy of the Company's shareholder list.³ This will permit the Company to provide notice and call a meeting of shareholders. The Custodian anticipates sending out notice of the upcoming meeting to all shareholders of record at an appropriate time before July 23, 2021.
6. Custodian retained professionals to prepare financial statements for filing with the SEC and OTCMarkets. Custodian considers the filing of current financial and corporate disclosures for WLYW a top priority—because with updated public disclosure, the Company and its stockholders will be able to eliminate the danger of the SEC's ordering a trading suspension based on concern about the quality of public information about the Company.

II. OTHER PENDING ISSUES.

A. SEC Constraints

Importantly, the Company is under time constraints to meet the SEC's recently imposed requirements for public companies operating under SEC Rule 15c2-11 that mandates the filing of current financial and corporate disclosures to be submitted to the SEC, and to have OTC Markets declare the Company "current" in its reporting status by September 28, 2021 to avoid permanent

1 suspension and revocation of its right to have its shares of common stock be traded on OTC
2 Markets.

3 **B. Identifying Potential Liabilities & Creditors**

4 In order to submit the required disclosures reports, Custodian needs to be able to
5 accurately identify all possible assets and liabilities of the Company. So far, the Custodian's
6 investigation reveals that WLYW has no assets and Custodian is now evaluating the best manner
7 of identifying and resolving any and all outstanding debts and obligations of the Corporation.
8 Custodian believes the claims process set forth in NRS 78.670 *et seq.* allows the Corporation to
9 re-establish financial clarity and certainty.

10 To that end, concurrently with this Interim Status Report, Custodian will be petitioning
11 the Court to require written proofs of claim against the Corporation pursuant to NRS 78.347(6),
12 NRS 78.635, and NRS 78.670 *et seq.*
