13 **ORDER APPOINTING PETITIONER AS CUSTODIAN [N.R.S. 78.347(1)(b)]**

14 THE COURT, having considered Petitioner, SHAREHOLDERS FIRST, LLC's  
15 Application and Motion for Appointment of Custodian for WALLY WORLD MEDIA, INC., a  
16 Nevada Corporation, pursuant to NRS 78.347(1)(b), proper notice having been given to the  
17 officers and directors of WALLY WORLD MEDIA, INC., pursuant to NRS 78.750(2), and no  
18 opposition having been received, and for good cause appearing,

19 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

20 1. Petitioner SHAREHOLDERS FIRST, LLC is hereby appointed custodian of  
21 WALLY WORLD MEDIA, INC.

22 2. Pursuant to NRS 78.347(3)(a), Petitioner shall comply with NRS 78.180 to  
23 reinstate and/or revive WALLY WORLD MEDIA, INC. with the Nevada Secretary of State.

1           3.     Petitioner is permitted to appoint new officers and directors for WALLY  
2 WORLD MEDIA, INC.

3           4.     SHAREHOLDERS FIRST, LLC is authorized to take any and all actions on  
4 behalf of the Company pursuant to NRS 78.347 that are reasonable, prudent or for the benefit of  
5 the WALLY WORLD MEDIA, INC., including but not limited to appointing interim officers  
6 and directors, negotiating and compromising debts, executing contracts and other agreements,  
7 authorizing and issuing new shares of stock, and authorizing new classes of stock, and initiating  
8 litigation in the name of WALLY WORLD MEDIA, INC.

9           5.     Petitioner shall provide reasonable notice of at least ten (10) days to all  
10 shareholders of record of a shareholders meeting that will be held within a reasonable time after  
11 this Order is entered, and that the shareholders who attend such meeting, whether in person or by  
12 valid proxy, shall constitute a quorum sufficient for all purposes of the meeting.

13           6.     The record transfer agent of WALLY WORLD MEDIA, INC. is hereby  
14 authorized and directed to cooperate with SHAREHOLDERS FIRST, LLC concerning the  
15 shareholder list for WALLY WORLD MEDIA, INC.

16           7.     Petitioner shall, pursuant to NRS 78.347(4), file an amendment to the Articles of  
17 Incorporation of the Company with the Secretary of State containing the following disclosures  
18 and statements:

- 19           a.     Disclosures of any previous criminal, administrative, civil or National  
20                    Association of Securities Dealers, Inc., or Securities and Exchange  
21                    Commission investigations, violations or convictions concerning the custodian  
22                    and any affiliate of the custodian.

- 1 b. A statement that reasonable, but ultimately unsuccessful, attempts were made  
2 to contact the officers and directors of the Company to request that the  
3 Company comply with corporate formalities and continue its business;  
4 c. A statement that petitioner is in fact continuing the business and attempting to  
5 further the interests of the shareholders;  
6 d. A statement that Petitioner will reinstate or maintain the corporate charter; and  
7 e. Any other information as may be required by regulations promulgated by the  
8 Nevada Secretary of State.

9 8. That while the custodianship remains active, every three (3) months or such other  
10 period that the Court determines, the custodian shall report to this Court concerning the actions  
11 taken by the custodian.
