

18 **ORDER REQUIRING WRITTEN PROOFS OF CLAIM**

19 THIS COURT, having considered the Custodian's Application to Require Written Proofs
20 of Claim, proper notice having been given, no opposition having been received, and good cause
21 appearing,

22 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that:

23 1. Pursuant to NRS 78.675, all claimants and creditors of WALLY WORLD
24 MEDIA, INC., a Nevada Corporation (hereinafter "WLYW"), shall have thirty (30) days from
25 the date of Notice of Entry of this Order to submit a written Proof of Claim delivered to the
Custodian:

1 2. Pursuant to NRS 78.680, all claimants and creditors of WLYW shall make their
2 proof of claim form under oath on the Proof of Claim Form available through the court.


3 3. The claimants and creditors of WLYW shall submit to examination at the
4 Custodian's discretion, and shall produce information and documentation as requested by the
5 Custodian.

6 4. Pursuant to NRS 78.675, the Custodian shall give notice to all possible and
7 potential claimants and creditors of WLYW by publishing this Order once a week for four (4)
8 consecutive weeks in the Nevada Legal News.

9 5. Pursuant to NRS 78.590(1), NRS 78.635(2)(c), and NRS 78.675, any claimants
10 and creditors of WLYW who fail to timely submit Proof Claim as set forth in this Order shall be
11 barred from later presenting their claim to WLYW.

12 6. Pursuant to NRS 78.685, within 60 days of the deadline to submit Proofs of
13 Claim, the Custodian shall move to resolve all claims received, and all claimants and creditors
14 whose claims are disputed or disallowed may oppose the Custodian's decision to the District
15 Court.
